Parent understands and agrees to the following Agreement on behalf of Parent and Minor and must sign and date this Agreement on the last page.

#### 1. Eligible Minor

A Minor is defined as a person under the age of 18. All Minors must have their Parent complete this Agreement and email to LinuxDojo prior to enrollment. Minors under thirteen (13) years of age are not eligible to attend LinuxDojo Training unless accompanied full time by Parent.

#### 2. LinuxDojo Training Is Not a School

LinuxDojo's training and certification services are not a “school” or “college” and are not accredited by any state or local education bodies. LinuxDojo Training is private training focused on hands-on skills at products and solutions designed for technically competent professionals. LinuxDojo Training does not position or market its services to minors. No special provisions or amenities or supervision for Minor participants are provided.

#### 3. LinuxDojo Does Not Act in loco parentis

LinuxDojo does not and will not act in loco parentis (“in the place of a parent”) with respect to a Minor while on LinuxDojo premises or in LinuxDojo Training. This means that Parent is entirely responsible for the care of the Minor at all times, even if Parent decides not to accompany or remain with Minor during LinuxDojo Training. LinuxDojo's duty of care for a Minor participant shall be no greater than for an adult participant.

#### 4. Parent or Chaperone May Accompany Minor

Parent or chaperone may accompany Minor to LinuxDojo Training or may allow Minor to attend unaccompanied. LinuxDojo requires Minor under 13 years of age to be accompanied by Parent or chaperone during LinuxDojo Training. Upon request LinuxDojo will provide seating for Parent or designated chaperone to accompany Minor during LinuxDojo Training. If choice of seating is desired please arrive at least 20 minutes early.

#### 5. Parent Responsible for Conduct, Care, Supervision and Safety of Minor

Parent is solely responsible for the conduct, behaviour, care, supervision and safety of Minor while Minor is on LinuxDojo premises or in LinuxDojo Training whether or not Parent or chaperone accompanies Minor. LinuxDojo Training is taught on live computer equipment in equipped IT training classrooms with unrestricted access to the Internet. Parent is solely responsible for Minor's use of the Internet during LinuxDojo Training.

#### 6. Right of Dismissal

LinuxDojo reserves the right to dismiss a participant from any LinuxDojo Training or exam event if the participant in LinuxDojo's sole judgement acts inappropriately or disruptively. In case of such dismissal, linuxDojo's liability will be limited to the refunding of any fees paid by participant or participant's organization in respect of the LinuxDojo Training and LinuxDojo shall not be responsible for any consequential loss or inconvenience arising whatsoever. In case of dismissal of a Participant who is a Minor unaccompanied by a Parent, LinuxDojo as a courtesy will make reasonable efforts to contact the Parent and chaperone/alternate adult at the contact numbers supplied by Parent, and notify of the dismissal of Minor.

#### 7. Terms and Conditions and Payment

LinuxDojo Training Terms and Conditions at [www.linuxdojo.com](http://www.linuxdojo.com) and elsewhere in connection with LinuxDojo Training shall apply to Minor as if Minor were an adult. Parent and Minor are responsible for Minor's compliance with Terms and Conditions. Parent is responsible for payment for LinuxDojo Training in accordance with LinuxDojo's payment terms, as described at [www.linuxdojo.com](http://www.linuxdojo.com).

#### 8. Minor to Sign Binding Agreements

LinuxDojo Training requires all Participants to sign and enter into a number of agreements including a Non-Disclosure Agreement ("NDA") that must be signed before taking LinuxDojo exams. The NDA requires the Minor not to disclose any details about the exam to others, either verbally, in print, in electronic form, or on the Internet. Should certification be earned Minor will be required to enter into a trademark usage agreement for the respective certification mark and logo that he/she has earned. These agreements are conventional and similar to those used by many IT certification exams. Copies of these agreements are available at upon request. Parent and Minor are responsible for Minor's compliance with such agreements.

#### 9. Release

I, on behalf of myself, my child, our heirs, executors, administrators, successor and assigns, hereby release and discharge LinuxDojo, its officers, directors, agents, and employees with respect to all activities associated Parental Consent Form with, or any damages arising out of the LinuxDojo Training and from any cause of action of any nature whatsoever arising from my child's participation in the LinuxDojo Training.

#### 10. Collection and Use of Information

I hereby consent and grant permission for LinuxDojo to collect, use, and transfer to third parties the personally identifiable information as needed for LinuxDojo to provide the LinuxDojo Training and, if earned, LinuxDojo certification credential(s) for my Minor child.
